## **OFFICIAL RULES**

The SiriusXM NFL Draft Broadcast Ticket Promotion ("**Promotion**") is subject to these Official Rules ("**Official Rules**").

**SPONSOR.** The Sponsor of this Promotion is Sirius XM Radio Inc., 1221 Avenue of the Americas, 36<sup>th</sup> Floor, New York, New York 10020.

**CONDITIONS OF ENTRY / ELIGIBILITY TO WIN**. **HOW TO ENTER.** If you are in Detroit, Michigan area, visit the Sirius XM NFL Broadcast Booth at Checker Bar Detroit ("**Venue**") on either April 25<sup>th</sup> or April 26<sup>th</sup> between 7 PM – 9 PM to get an entry ticket ("**Ticket**"). There will be one drawing on or about 9 PM each day (each, a "**Daily Drawing**"). Only Tickets distributed for a particular day will be eligible for that day's Daily Drawing. Only one (1) Ticket will be issued to each person for a Daily Drawing. Each person receiving a Ticket shall be considered an Entrant. **Entrants must be present at the Venue at the time of their applicable Daily Drawing to win**.
