OFFICIAL RULES

Open only to legal residents of the United States, DC, and Puerto Rico, who are at least 18 years of age at time of Entry.

ENTRY PERIOD: The "**Entry Period**" for the DC Shoes x Black Sabbath Tribute Vinyl Ozzy's Boneyard SiriusXM Social Giveaway ("**Sweepstakes**") begins November 23rd, 2021 at 12pm EST and ends December 09, 2021 at 8pm EST.

HOW TO ENTER: To enter, entrants must **(1)** "**like**" the sweeps graphic ("**Graphic**") appearing on SiriusXM's Ozzy's Boneyard channel (@sxmozzysboneyard) on Instagram; **(2)** "**follow**" Black Sabbath (@blacksabbath) and SiriusXM's Ozzy's Boneyard channel (@sxmozzysboneyard) on Instagram; **(3)** "**tag**" a friend's account and "**hashtag**" #SXMsweepstakes; **(4)** is at least 18 years of age at the time of entry; and **(5)** a legal resident of the United States, the District of Columbia, or Puerto Rico. LIMIT ONE comment / entry per person. Incomplete entries will not be considered.

CONDITIONS OF ENTRY / ELIGIBILITY TO WIN: Entrants agree to abide by the terms of these Official Rules and by the decisions of Sponsor which are final and binding.
